

What does kinder cost? - Government Funded Free Kinder

Free Kinder will be available for both 3 and 4 year old kindergarten programs from 2023.

A critical part of the Best Start, Best Life reform is Free Kinder, which will support access to two years of high-quality kindergarten programs for all Victorian children by making this free.

This means that in our short day program children attend 15 hours of kindergarten for free. In our long day program the kindergarten component is subsidized by the government, however we charge a before and after 'care component' to allow children to attend two long days per week. This allows children to attend longer than the 15 hours per week (7.30-6pm). This is called the

How many hours kindergarten will Pre-kinder and four year old kindergarten receive at GSK in 2023?

Both the three year old and four year old program will provide each child with the full amount of 15 hours per week.

When can my child commence three-year-old Kindergarten?

Your child needs to turn three years old before the end of April in the year they commence three year old kindergarten. Your child cannot attend three year old kindergarten if they are two years old. They cannot attend until they are three years old. The Department of Education states that research shows that quality play-based learning is a powerful way to support children's learning and development. The benefits last into the school years and beyond. Evidence also shows that two years are better than one when it comes to early learning. Taking part in a quality kindergarten program at an earlier age leads to positive effects on child development. It has even greater benefits for children who need extra support or are in vulnerable circumstances.

Can my child have two years of three or four year old kindergarten?

Three Year Old Kindergarten

No. Your child can only have one year of funded three-year-old kindergarten. Then they must commence a four year old kindergarten program.

We strongly encourage families to **consider** when to start their children at three year old (Pre-kinder). Children Turning three at the beginning of the year may benefit from waiting until the following year to begin kinder. Please discuss your options with Educators to learn more.

For the following reasons:

-The first five years of a child's life are the foundation stones for learning, by giving them more time, you are giving them every opportunity to reach their full potential.

-A second year of funding for your child cannot be given unless your child is showing *delays in several areas of development*. Only then can this warrant a second year of four-year-old kindergarten. Immaturity is not usually a consideration. *The Department of Education states:*

There may be a small number of children for whom a second year of kindergarten is appropriate. Your child may be eligible if: -your child's teacher has found they have developmental delays in at least two key areas of learning and development, and -your child will have better outcomes through a second year of kindergarten than going to school.

What are some of the benefits of staying with us for two years?

-Our Social and Emotional Intelligence Programs (RULER APPROACH & You Can Do It Program) can be embedded in your child's learning over two years prior to school, cementing a great foundation for developing social and emotional intelligence. -Continuity of Educators, by allowing your child to remain in the same environment with the same group of peers and educators for a minimum of two years ensures continuity of care and promotes the importance of meaningful and deep relationships and quality learning experiences.
